Course prerequisites, co-requisites, enrollment restrictions: None

Course Description: The class explores the economic basis of environmental problems and provides an accessible approach to how economic concepts can be applied to guide environmental policy. Market failures that give rise to excessive air and water pollution, land degradation and biodiversity loss are presented alongside potential market-based solutions. We also examine approaches to natural resource valuation techniques and the economic underpinnings to the management of renewable and non-renewable resources.

Student Learning Outcomes:

- A basic familiarity with the economic paradigm of thinking as it applies to natural resource management and environmental challenges.
- Gain a working knowledge of economics jargon as it applies to solving society's most pressing environmental challenges.
- Ability to leverage economic thinking to design and evaluate appropriate environmental policies.

Required texts, readings, and special tools or materials:

Environmental Economics and Policy (Lewis and Tietenberg, 7th edition), Routledge Press.

Environmental Economics and Policy Brief/Case Study (30% of final grade):

Students will produce a professional policy brief on an environmental/natural resource economics case study/application relevant to course material. Example concepts include but are not limited to the following:

- 1. Blue Carbon Markets and Developing Countries
- 2. Transboundary Considerations of Fresh Water Provision
- 3. Renewable Energy Portfolio Standards and Cross-State Externalities
- 4. Local Adaptation to Climate Change in the Wine Industry
- 5. Adaptation through Migration and Climate Change
- 6. Climate Change Considerations in Global Fisheries Markets
- 7. Natural Wealth Accounting and Implications for Wyoming
- 8. Entrepreneurial Approaches to Payments for Ecosystem Services
- 9. Entrepreneurial Approaches to Natural Resource Valuation

- 10. Entrepreneurial Approaches to Climate Change Mitigation in Urban Areas
- 11. Roles of Charisma and the Joint Management of Endangered and Invasive Species
- 12. Environmental Justice and Reproductive Health
- 13. Global Environmental Agreements and Governance: From Rio to Glasgow and Beyond
- 14. Global Pandemic Risk and Climate/Environmental Policy

Each case study will include topic background, review of relevant literature and policy efforts, an economic analysis that applies concepts learned in class and suggested policy considerations and approaches to resolving the environmental challenge.

Each case study should be 3 <u>concise</u> written pages using side 12 Times New Roman. Figures and diagrams can be included but only to the extent that they support the written material in the policy brief (e.g., avoid non-substantive images that do not add analytical support to the policy brief such as a picture of a charismatic polar bear or a rainforest).

Each student will submit 3 drafts that will receive thorough feedback from the instructor. The project will be worth 30% of your final grade.

Draft 1 – 5% of your final grade.

Draft 2 – 10% of your final grade.

Final Draft 3 – 15% of your final grade.

Each draft will be graded on your ability to respond to the detailed feedback received by the instructor including writing quality, concise communication, policy brief depth and displaying a clear understanding of how economic concepts apply to and inform the policy context of the given environmental challenge.
